## Names, name changing and lepidopterists

We as lepidopterists are always busy with names, the names of our pet species, those of the hostplants and the parasitoids, and we all know that no name is stable for ever. We are used to names changing over time due to new insights in taxonomy or for nomenclatorial reasons. Still, it can annoy us when many names suddenly change and sometimes we wonder if this was really necessary. The contribution by Martin Corley in this SELepidoptera News deals with that problem: as somebody making checklists he is often confronted with such changes and wonders in particular if changes of generic names are really needed. I do agree with his point of view, and I would in fact go further than he does and suggest the use of species groups rather than subgenera in cases like *Eilema* that he presents as example. Although the basic research that leads to such changes may have been well done and provides good arguments for the recovered phylogeny, the decision to name a branch of a phylogenetic tree as a genus (subgenus) or a species group is still totally subjective. In my opinion, one should aim at keeping generic nomenclature intact for as long as possible and try to arrive at recognisable entities. In micromoths we have large genera that are perfectly well recognisable and divided more usually into species groups than subgenera, such as *Phyllonorycter*, *Coleophora*, *Stigmella*, *Argyresthia* and many more. Attempts to split some off these (as subgenera) have not worked out well. To trust detailed genitalic characters too much at the generic level is dangerous, as such characters are prone to fast evolution, due to sexual selection, and could easily result in oversplitting. Luckily, we see a tendency in studies on some groups such as butterflies and noctuids to return to larger genera, rather than oversplitting. After all, most of us would prefer a stable nomenclature.

As society we are also dealing with names, in this case the name of our own society, that we have changed in the last General Meeting into “SEL Society for European Lepidopterology” as you could read in SELepidoptera News 67, page 5. Like in Zoological nomenclature, where the International Commission for Zoological Nomenclature can decide against incorrect name changes, we are also confronted with a legal body, in this case the German Vereinsregister, that has to check whether the conditions were correct to accept the new statutes. Unfortunately, they could not accept the last minute change of the name during the 2022 Congress, as that name was not announced in the invitation for the meeting and they have a point, of course. Hence, they have registered the Statutes as accepted in the first place, with the name “SEL Society of European Lepidopterists” that most of us who were present in Laulasmaa did not want. We have now to use that name formally in our invitation, to make it legal, but hope that members will vote in favour of the better name “SEL Society for European Lepidopterology”. If you are not coming to the Congress, you can send your vote by e-mail, see elsewhere in this issue.

Another issue with names are our own names: since 2016 is the GDPR (General Data Protection Regulation) European policy and protects all civilians against misuse of personal data. This has led to the fact that we no longer provide a free list of members with address data as we did before to prevent misuse. However, we realise that a list of members can be very important for getting into contact with people with similar interests (as it used to have indication on specialties), and also for acting your democratic rights. We therefore will ask the General Meeting permission to prepare a membership list, for which each member can give his/her consent.

This is the last item that I am writing for this newsletter as president of the Society, and I was honoured that I have been able to serve you in this capacity. I appreciated the collaboration with many council members and many other SEL members, and enjoyed the meetings immensely. I hope to meet you in Orléans and after that in many more meetings to come,

**Item 7a.** Council proposes to change § 1.1 of the Statutes that were accepted by the General Meeting 2022 in Laulasmaa as follows:

**OLD.** § 1 Name, registered office, financial year

1. The name of the Society shall be "SEL Society of European Lepidopterists", founded as SEL Societas Europaea Lepidopterologica e.V. on 19 September 1976. The Society's registered office shall be at Karlsruhe in the Federal Republic of Germany. The Society has been registered at the district court at Mannheim under Nr. 101146.

**NEW.** § 1 Name, registered office, financial year

1. The name of the Society shall be "SEL Society for European Lepidopterology", founded as SEL Societas Europaea Lepidopterologica e.V. on 19 September 1976. The Society's registered office shall be at Karlsruhe in the Federal Republic of Germany. The Society has been registered at the district court at Mannheim under Nr. 101146.

#### Explanation:

During the 2022 General Meeting in Laulasmaa, the members voted to

change the name of SEL from Societas Europaea Lepidopterologica to "SEL Society of European Lepidopterologists" and adopted the amended Statutes with this name. After the meeting, this name was changed to "Society for European Lepidopterology" because members were concerned that the originally proposed name would exclude non-European members. Although the majority of members present at the Congress approved this change one day after the General Meeting, this did not happen at the formally announced General Assembly. Therefore, the Mannheim Register of Associations, where the Society is registered, did not accept this second change of name. For this reason the new statutes were registered under the name "SEL Society of European Lepidopterologists" ([statutes](#)). We ask the members to vote for the change of § 1.1 of the statutes and the change of the name of our society to "SEL Society for European Lepidopterology". In case of rejection the name will remain "SEL Society of European Lepidopterologists".

**Item 7b.** Council proposes to prepare a list of members. Due to the European GDPR SEL hasn't had a formal membership list for several years. As we would like to promote the possibilities of members to be able to contact each other, council will prepare a membership list with at least name, email, country and area of expertise. Members should give their consent and if they wish we can add more address details. Council will work out whether the list will



be published on paper, as pdf or on the website in a member only area.

**Item 7c.** Council proposes the following membership fees from 2024 onward:

- Normal membership with printed *Nota Lepidopterologica*: € 70 (including corporate members)
- Normal membership without printed *Nota Lepidopterologica*: € 50
- Student membership without printed *Nota Lepidopterologica*: € 30

Members who pay with SEPA direct debit get a reduction of €5 on their fees (thus resp. € 65, 45, 25)

Members wishing to receive printed *Nota* should have paid their fees before November 1st, otherwise *Nota* will not be sent. Members who haven't paid in the calendar year get one chance after a reminder to pay for 2 years; otherwise they will be deleted as a member. Council will set a deadline for payment.

Student members can be BSc, MSc or PhD students or high school pupils.

**Item 10.** Election of Council members. The 4-year terms of Erik van Nieuwerkerken (President), Thomas Simonsen (vice-president) and Marianne Espeland (general secretary) end, they are not available for a new term. Also the 4-year terms of Hossein Rajaei (membership secretary) and the ordinary council members Enrique Garcia-Barros and Carlos Lopes Vaamonde ends. They are available for re-election in this function.

Council proposes the following new candidates:

Jadranka Rota as President, Toomas Tammaru as Vice-President, Richard Mally as General Secretary,

and Marianne Espeland and Zdeněk Faltýnek Fric as ordinary council members.

**Item 12.** The 4-year term of Axel Steiner ends, council is looking for a candidate to replace him.

**Item 14.** Members' proposals: any proposals by members are to be submitted in writing to the General Secretary, Marianne Espeland by 1<sup>st</sup> August 2023.

**Ancienne version.** § 1 Nom, siège, année d'exercice

1. La Société dénommée « SEL Society of European Lepidopterists », a été fondée sous le nom de SEL Societas Europaea Lepidopterologica e.V. le 19 septembre 1976. Elle a son siège social à Karlsruhe dans la République Fédérale d'Allemagne. Elle est inscrite au registre des sociétés de l'Amtsgericht de Mannheim sous le numéro 101146.

**NEW.** § 1 Nom, siège, année d'exercice

1. La Société dénommée « SEL Society for European Lepidopterology », a été fondée sous le nom de SEL Societas Europaea Lepidopterologica e.V. le 19 septembre 1976. Elle a son siège social à Karlsruhe dans la République Fédérale d'Allemagne. Elle est inscrite au registre des sociétés de l'Amtsgericht de Mannheim sous le numéro 101146.

### Explications:

Durant l'Assemblée Générale de 2022, à Laulasmaa, les membres ont voté en faveur du changement de nom de la SEL de Societas Europaea Lepidopterologica en « SEL Society of European Lepidopterists » (=Société des lépidoptéristes européens) et accepté le changement corollaire des statuts de l'association. Après cette AG, le nom fut transformé en « SEL Society for European Lepidopterology » (=Société pour la lépidoptérologie européenne) à la suite d'avis de plusieurs membres qui craignaient que la formulation initiale exclue les membres non européens. Bien que la majorité des membres présents au congrès aient accepté cette nouvelle modification un jour

après l'Assemblée Générale, cela ne s'est pas déroulé durant la séance officielle de l'AG. Le service du registre des associations de la Cour du district de Mannheim, où la SEL est enregistrée, n'a pas validé ce deuxième changement de nom.

C'est la raison pour laquelle les nouveaux statuts ont été enregistrés sous le nom de « SEL Society of European Lepidopterologists » ([statuts](#)).

Nous demandons aux membres de voter uniquement pour la modification de § 1.1 des statuts et pour le changement du nom de l'Association en « SEL Society for European Lepidoptology ».

En cas de rejet, le nom restera « SEL Society of European Lepidopterists ».

**Point 7b.** Le Conseil propose de préparer une liste des membres. En raison de la GDPR (CNIL) européenne, le SEL n'a pas diffusé de liste formelle des membres depuis plusieurs années. Comme nous souhaitons promouvoir les possibilités de contact entre les membres, le Conseil préparera une liste des membres avec au moins le nom, l'adresse électronique, le pays et le domaine d'expertise. Les membres devront donner leur accord et, s'ils le souhaitent, nous pourrons ajouter d'autres adresses. Le Conseil déterminera si la liste sera publiée sur papier, en format pdf ou sur le site web dans une zone réservée aux membres.

**Point 7c.** Le Conseil propose les cotisations suivantes à partir de 2024 :

- Adhésion normale avec Nota Lepidopterologica imprimé : € 70 (y compris les membres corporatifs)

Während der Generalversammlung 2022 in Laulasmaa stimmten die Mitglieder über die Änderung des Namens der SEL von Societas Europaea Lepidopterologica in "SEL Society of European Lepidopterologists" ab und nahmen die geänderte Satzung mit diesem Namen an. Nach der Versammlung wurde dieser Name in "Society for European Lepidopterology" geändert, da die Mitglieder befürchteten, dass der ursprünglich vorgeschlagene Name außereuropäische Mitglieder ausschließen könnte. # In defence of the Subgenus

Martin Corley

Having produced a checklist of Portuguese Lepidoptera (Corley, 2015), I now have the self-imposed task of keeping this up to date with annual summaries of additions to and deletions from the fauna. Added to these changes there are changes at genus level to be considered and it is here that it starts to get complicated.

A genus is a collection of species (sometimes just one species) that are believed to be more closely related to one another than to species in another genus. In other words, they represent a single branch of the evolutionary tree. Herein lies the problem. Is it a stout branch with smaller branches before it ends in twigs (species) or a more slender branch with fewer twigs? In other words, is the taxonomist who defines the genus a lumper or a splitter? There is a prevailing tendency for large genera to be carved up into smaller genera each containing fewer species. Occasionally small genera are amalgamated into larger genera, but this does appear to be less frequent in recent years. There is also sometimes a pendulum effect, in which one or more species are removed from a larger genus, only to be reinstated in the original genus by a different author a few years later. This is particularly prevalent in Rhopalocera, but also occurs in Heterocera.

For the checklist compiler, changes at genus level make extra work, which is of questionable value. For the consumer (anyone who wants to know the correct name of a taxon) it causes confusion. Taxonomists would do well to remember that theirs is a service industry. They are providing a framework of information for others to use. This is of much less value if it keeps changing.

I take as an example the recent publication of a revision of European and North African *Eilema* Hübner (Maciá et al., 2022), but there are many other examples. Everyone recognises an *Eilema* – they have long more or less unicolorous forewings, often with a

pale costa, either wrapped round the body or resting in a flat position over the back. Now if I follow Maciá et al. the Portuguese species fall into eight different genera. Only one species remains in *Eilema* and we have to learn new genus names for all the remaining species. I can see no benefit to me or to any field lepidopterist in this.

I am not criticising the scientific quality of this paper and I understand the authors' intentions. Their small genera highlight the different evolutionary branches within the *Eilema* group. In the case of *Eilema*, substantial division of the genus had already been proposed by Dubatolov & Zolotuhin (2011) among others. In applying this work to 21 western Palearctic species, some species did not fit comfortably into the Dubatolov & Zolotuhin genera, so the necessity appeared to be the creation of further new genera. Once one starts splitting it is hard to know when to stop. The result is that 12 of the 21 species fall into two genera, while the remaining nine species are in nine different genera, some of which are monotypic, others have additional species in other parts of the world.

Such studies are usually based on the species of a relatively small geographical area (often Europe) but may give little or no consideration to the related species in other parts of the world. Without a global revision the results are inevitably questionable, as there is a significant probability that there are species elsewhere in the world that occupy an intermediate position between the new genera.

Whatever happened to the subgenus? It is the perfect vehicle for these small or monotypic "genera", while allowing all the similar species to remain in a single large genus and it sidesteps the need for monotypic genera. Anyone not interested in the minutiae of evolutionary relationships can just ignore the subgenus as it does not form part of the species name.

There is another alternative. Some lepidopterists make use of "species groups" which are not part of the formal hierarchy but can still associate similar species. Groups may be given numbers or named after a representative species within the group and if required can be further divided into subgroups. They allow some degree of structure in very large genera such as *Coleophora* Hübner, *Elachista* Treitschke and *Idaea* Treitschke which can make species identification in such large genera much less daunting.

I do not propose that no-one should ever erect a new genus. There are circumstances in which it becomes necessary, as when I realised that the gelechiid genus *Sophronia* Hübner contained species belonging to two different subfamilies. This necessitated the description of the new genus *Pseudosophronia* Corley. I was also involved in the description of another gelechiid genus, *Mondeguina* Corley & Rosete, because its type species did not have the morphological characters of the genus (*Apatetris* Staudinger) in which it had been described. But I am suggesting that anyone proposing a new genus should think very hard before deciding that it would not be better described at subgenus level.

Dear Lepidopterists,

For a couple of years now, together with our dear colleagues David Lees and Niklas Wahlberg, we have been running the project on the phylogeny and biogeography of an endemic Madagascan lineage of Syntomini tiger moths. This group comprises nearly 100 species, but was very poorly studied. Our phylogenetic research is almost done, and at the final stage of the project we are preparing the distributional atlas of Madagascan Syntomini. We hope that it will contribute not only to the more detailed knowledge of our focal group, but also to a better understanding of the biogeographic patterns of the island's extraordinary fauna. We already have gathered a huge dataset, comprising label data from over a thousand of specimens, both from our own collecting and from the most important museum, including NHMUK London, MNHN Paris, SGN Frankfurt am Main and PZBT Tsimbazaza. We examined also specimens from several further collections: MfN Berlin, NRM Stockholm, Naturalis Leiden, SMNS Stuttgart, MLUH Halle and OUMNH Oxford. Here we would like to express our gratitude to all our colleagues from the institutions mentioned above, for their kind and generous help with collecting the data.

However, even a single specimen or a photograph of an individual from a locality that has never been reported before brings very precious information and improves the geographical coverage of the dataset. Therefore, we invite you to sending us the specimens or photographs of Madagascan Syntomini. We would be grateful also for sharing this information with anyone you know may have such materials. Specimens and data contributions from collectors and collections will be acknowledged in the publications arising from this work.

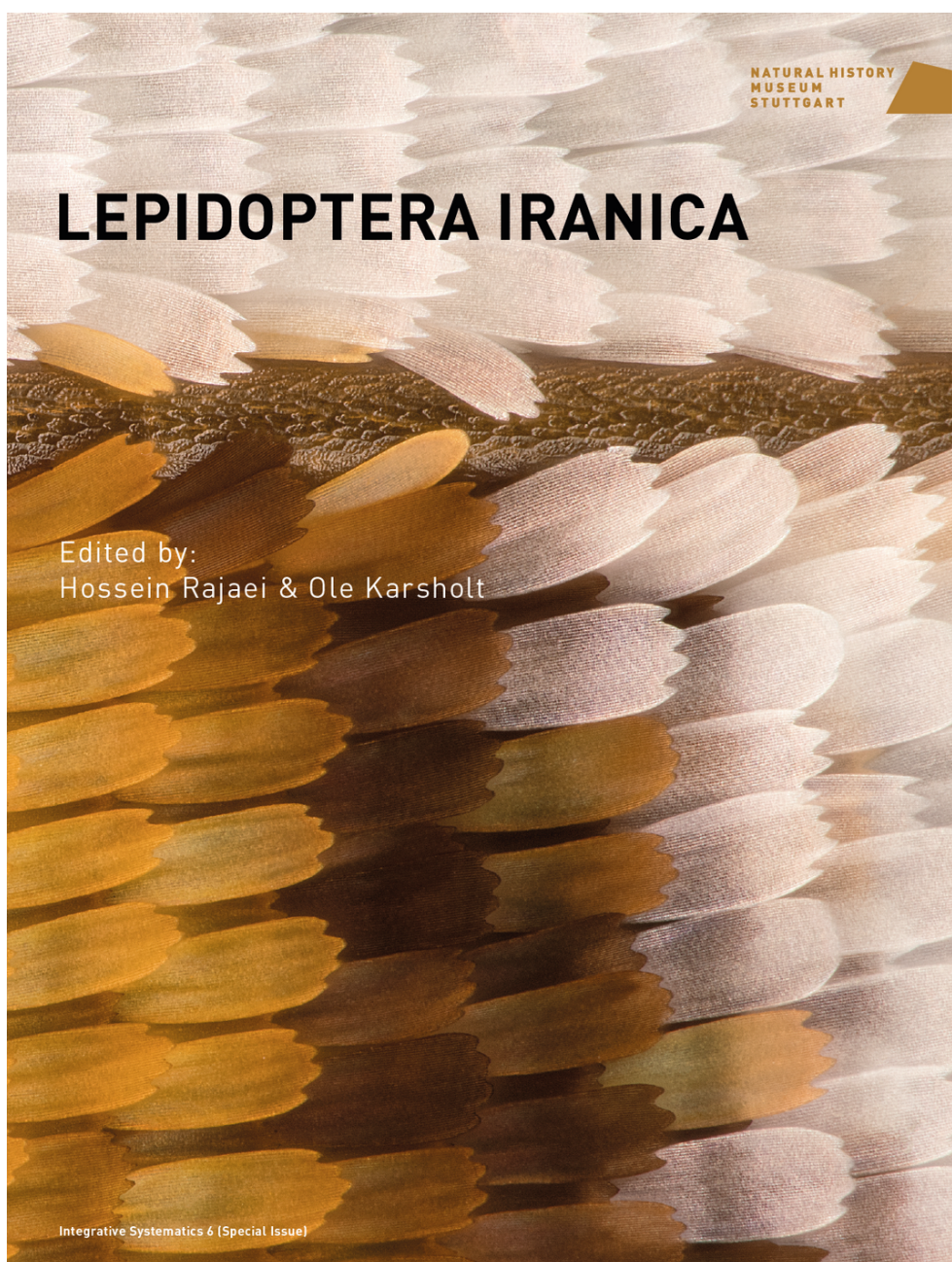

### Local SEL representatives instead of local treasurers

The system of local treasurers, then termed “regional collecting agents”, was established in 1994 as a consequence of raising costs of international payments (see News 22). Since then a lot has changed, and now, due to the introduction of the EURO and the SEPA payment area, direct transfers from most European countries to Germany are comparable to domestic transfers, with few or no extra costs for payments in EURO. For other countries we have opened a PayPal account, to be able to pay with credit cards.

As the system with various local treasurers is an extra burden for the bookkeeping, and no longer needed for cost reduction, council has decided at its meeting in Campobasso to abandon the long-standing system of local treasurers and from now on only accept direct payment by members to the treasurer. We have discussed this step already for some years, and more and more members pay directly, and some local treasurers already stopped.

However, we realise that the local SEL treasurers paid also an important role to represent SEL in their country, as they are closer to the members. As it is important for SEL to have local contacts, we asked first the former local treasurers to consider changing their role into local contact person of SEL for their country. A local contact person would be a great help, especially if members have questions about the next congress, the recruitment of new members or the direct payment of fees.
